1. Collection and Use of Personal Data

a. Purpose of Processing and Legal Basis

The Company will collect your personal data (which may include sensitive personal data) and will process your personal data for the purposes of providing you with work-finding services. The legal bases we rely upon to offer these services to you are:

- Consent
- Legitimate interest
- Legal obligation
- Contractual obligation

b. Legitimate Interest

Where the Company has relied on a legitimate interest to process your personal data our legitimate interests are providing work finding services to work-seekers.

c. Recipient/s of data

The Company will not process your data with any third party.

d. Statutory/Contractual Requirement

2. Overseas Transfers

The Company may transfer only the information you provide to us to countries outside the European Economic Area ('EEA') for the purposes of providing you with work-finding services. 3. Data Retention
